36.0. AGRICULTURAL IRRIGATION LOAD CONTROL SERVICE RIDER

36.1. AVAILABILITY

This Rider is offered in conjunction with the Entergy Arkansas, Inc. ("EAI" or the "Company") Agricultural Irrigation Load Control Program ("Program") developed pursuant to the Arkansas Public Service Commission's Rules for Conservation and Energy Efficiency Programs. This Rider is offered to customers who are currently taking service under EAI's Rate Schedule No. 14 (Agricultural Water Pumping Service). To participate in the Program, an eligible customer must permit the Company to install a control device at Company's expense so that Company can control the operation of the customer's pumping unit during periods of Company's peak load conditions. This Rider will be in effect for the time period defined in § 36.4, Service Period. (RT)

36.2. CREDIT

The customer will receive a credit per kW, as shown below, based on the current month's established billing load for each of the customer's three peak billing months, depending on the cycle in which the customer is billed pursuant to the Company's Agricultural Water Pumping Service Rate Schedule (AP), § 14.4.4. Said credit shall not exceed 30% of the customer's bill before the application of adjustments. (CT)

Demand Credit per kW: \$4.16 per month

The Company shall have the right to interrupt service to the pumping unit for up to 3 hours per day excluding weekends and holidays from June 1 through August 31 (the Peak Billing Season). The period during which service interruptions may occur shall begin at noon and end at 9:00 PM. (RT)

Company reserves the right to change the hours of interruption at the beginning of each Peak Billing Season.

36.3. OTHER PROVISIONS

36.3.1. The customer shall be responsible for the repair and maintenance of the customer's equipment including the pumping unit and for keeping such unit in good repair and working order. (CT)

- 36.3.2. The Company shall be responsible for the repair and maintenance of Company's equipment including the control device. (CT)

- 36.3.3. If the customer chooses to discontinue service under this Rider other than as provided in § 36.4 below, upon notification by customer, Company will promptly discontinue the service and customer will repay to Company the amount of any credit previously made on customer's bill during the current season. Notification should be provided to the Company by U.S. Mail or e-mail as instructed in § 36.4. (AT,RT)

- 36.3.4. If there is evidence of alteration of or tampering with Company's control device, customer will reimburse Company for the cost of replacement or repair of the control device and the credit to customer's bill during the season as it is defined in the Company's Agricultural Water Pumping Service Rate Schedule (AP) and Company may cancel service under this schedule and remove its control device. If Company elects to cancel service under this schedule and remove its control device as a result of tampering, customer will pay to Company its removal cost. (AT,RT)

- 36.3.5. The customer agrees to allow Company representatives to have access to the pumping unit for the purpose of installing, testing, and maintaining the remote control device at all times. (AT)

- 36.3.6 If the customer is not the owner of the pumping unit(s), the customer shall furnish the Company the owner's written consent for the installation of the control device. (AT)

- 36.3.7 A customer choosing to take service under this Rider will be required to provide confirmation to the Company of their intent to participate in the Program by providing a list of the customer's water pumping units which shall be included in the Program. (AT)

- 36.4. **SERVICE PERIOD** (AT,RT)

Service under this Rider shall be during the Peak Billing Season of the current year and shall be automatically renewed for successive Peak Billing Seasons in succeeding years unless terminated by notice given by the customer to the Company not less than three months prior to the beginning of the customer's next pumping season. (AT,RT)
